#### **Research Paper Requirements**

- A researched paper of no fewer than six and no more than eight pages.
- The entire paper will demonstrate understanding of MLA format.
- The paper will contain:
  - The history of the crime.
  - Its historical/cultural significance.
  - Controversies and theories about it.
  - A discussion of ongoing concerns/guestions about its resolution.
  - A discussion of how prevalent this crime is.
  - Your group's theory about what really happened.
- It is critically important that your paper include quality, academic research. If you ask for help finding • good research, I will assist. Make sure to request assistance soon.
- Your paper should include a minimum of 12 sources, at least four of which need to come from academic sources.
- No more than two groups may select the same topic. If more than one does, you will need to change to a new topic.
- You may work in groups ranging in size from one to four.
